They follow **the full teaching programme**, and are subject to the same assessment procedures as the regular ENSBA students.

The number of students accepted for Graphic design (Licence) and Textile design (Licence) is limited. The limitations are: one student, per semester, per option and this is only offered to the 2<sup>nd</sup> year student.

Applicants must provide the following documents:

- Artistic Portfolio (CD or DVD Supports in PDF format)
- Cover letter and Curriculum Vitae both in French
- Photocopy of valid id card or passport
- 2 passport photos

After acceptance, the student must provide the following documents upon his arrival at the Lyon ENBSA:

- Certificate of Personal Liability insurance translated into french
- Original birth certificate with a translation into french from an approved translator.

### **\*Insurance**

#### **1. Insurance of civil liability:**

An insurance of civil liability is a compulsory insurance for all the students of the ENSBA Lyon. The contract is often associated with the housing insurance, even with the insurance transports. Concretely, the civil liability is the obligation to compensate any damage or accidents which you cause to others in your private or university life. The Individual accident insurance covers physical injury (in particular when you are the victim of an accident).

All foreign residents who have lived in France for more than 3 months can open a bank account. We advise you to open a bank account in your own name, here in France so that you may receive an accommodation grant and refunds for medical expenses by LMDE or SMERRA, these will be transferred to your account automatically.

#### **1. French social security:**

A.1.1 A student will be registered with social security at the same time s/he registers with her/his institution of higher education:

A.1.2 - A student from the EEE or Switzerland who has a European Health Insurance card (or document certifying this) or a certificate from a private health insurance company covering him for the entire university year (from October 1st to September 30th of the following year), with no refund limit, a contract in French saying how long it is valid. Remember to validate the European Health Insurance Card on arrival in France (with CPAM or your complementary health insurance), to be entitled to complementary health care benefit.

- On arrival at the ENSBA Lyon, all international students from outside the E.E.E., for a stay of longer than 3 months, must register with French Social Security (state health coverage with partially reimburses the cost of medical treatment), and pay the associated registration fee through the school. This is different from registration fees with the ENSBA. For your information, the cost, for the academic year 2013-2014 was 211€ (cash). Each student can add to this compulsory fee with some complementary private health insurances if they so wish. As a student, you will automatically have social security and can take out a complementary medical insurance. LMDE and SMERRA both offer social security and complementary medical insurance.
